Community Recovery Fund Awards Grant to Maria Carrillo High School

\$7,000 grant will help athletics department replace lost Track and Field equipment

UKIAH, Calif. Most of the Track and Field uniforms and equipment were stored at the coaches' homes, as there was not enough secure storage on campus for the items. The estimated loss runs just over \$15,000.

"Replacing this equipment is a small but important step in recovery for the Maria Carrillo student families," said Bob Mertz, CEO. "Reflecting pride in their community identity, and representing Santa Rosa with distinction, is unified through a team of uniquely talented athletes sharing the same colors and mascot. It's another way to feel like every day life is returning."

The **Redwood Valley and Santa Rosa Community Recovery Fund** was established by the Mendocino Family of Companies through the Community Foundation of Mendocino County to support community restoration for youth, elderly, educators, emergency workers, and animals affected by the devastating Nuns, Redwood Valley, and Tubbs fires. Funds will be disbursed by the Community Foundation of Mendocino County via an independent committee, until the fund is exhausted.
