MRC wants a Measure M refund

The Mendocino Redwood Company's attempt to get a refund on taxes it paid after the 2014 passage of the Measure M parcel assessment funding the Albion-Little River Fire Protection District was heard in Superior Court in Ukiah Friday and Monday. Judge David Riemenschneider did not make a decision in the case.

MRC is suing Mendocino County, which collects Measure M revenues, saying that the company is exempt from local fire protection costs since its property in the ALRFD is also under CalFire's jurisdiction.

Fire district representatives argue that the company benefits from ALRFD's services, and that MRC has waited too long to challenge a tax that at least one executive had said the company would be willing to pay.

In a November 2014 video interview, shortly after Measure M passed, MRC Executive Vice President for Forestry Dennis Thibeault said that the company was well aware of the implications of Measure M and had decided not to oppose it.

"Most timber companies would have opposed a measure like that," he says. "And we chose not to. We chose not to so we could participate in this community, so that we could fund the local fire department. Those were conscious decisions that we made."

The basis of the complaint stems from Health and Safety Code 13811 which defines the types of lands that can be included in districts, including fire protection districts:

"Territory which has been classified as a state responsibility area may be included in a district, *except for commercial forest lands which are timbered lands declared to be in a state responsibility area.*" (Emphasis added.)

MRC lands are commercial forests in state responsibility areas. MRC attempted to work with the Albion-Little River Fire Department by appealing this tax to their board. The appeal was denied.

Subsequent to this video it became apparent after reviewing the Health and Safety Codes that MRC forestlands were not legally part of the ALRFD district. It is at that time we brought the issue to the ALRFD board to appeal the tax. This appeal was denied.

Cal Fire agrees state responsibility areas that are commercial forest lands cannot be part of a district.

MRC has supported numerous fire protection districts when requests are received for assistance. This assistance has taken the form of:

a. Partnering with communities to place dedicated firewater tanks, improve egress for remote neighbors and coordination of activities with local fire districts.

A representative for MRC this week declined to comment until the case is decided.	c. Donations of time, equipment and money to Volunteer Fire Departments.
ALRFD Chief and Fifth District supervisorial candidate Ted Williams said Monday that the local department responds to incidents on MRC land and should be compensated.	
"The largest land owner in our county has fought against paying the special tax residents pay," he stated in an email. "This case raises important public policy concerns about funding of emergency services. Local fire departments are almost always first at scene. They respond to fires on forest land, but they also provide emergency response to logging accidents, in some cases where local two-wheel drive ambulances cannot transit.	
"CalFire firefighters are skilled and put their lives on the line for us, but their stations are typically not staffed year round and their scope of capabilities is more narrow. Local fire districts cover all risk throughout the year with very little funding, many operating on bake sales and with volunteer labor. Out of general fairness, all land owners should contribute."
